### **Profile**

Delaney is experienced in assisting nonprofits and exempt organizations meet their charitable and philanthropic missions.

Delaney's practice includes working with nonprofits and exempt organizations at each phase of their lifecycle. She is experienced in establishing new nonprofits and drafting their formation and organizational documents in preparation for filing with the New York Department of State, including certificates of incorporation, articles of organization, bylaws and operating agreements. Delaney also assists nonprofits with implementing policies to comply with their legal and fiduciary duties under the New York Not-for-Profit Corporation Law and the New York Prudent Management of Institutional Funds Act, including conflict of interest, whistleblower and investment policies.
