Overview

With the enactment of the Marihuana Regulation and Taxation Act (MRTA) in 2021, New York State entered the unsettled legal landscape of the multibillion-dollar cannabis industry, with its complex web of regulations affecting cultivators, processors, retail dispensaries, distributors, delivery services, employers and municipalities. Following the enactment of MRTA, the cannabis space has continued to grow, which brings not only expanded opportunities, but also complex legal challenges in what will be a highly regulated industry. New York's 'budding' cannabis industry now includes opportunities for those interested in recreational adult-use cannabis, medical cannabis and cannabinoid hemp and cannabidiol (CBD).
