## Program Summary

With the continuing changes in Immigration Law, employment of foreign born professionals at our academic campuses has become more complex with each passing year. Given the foregoing, the Immigration Law Webinar will cover areas which include: (1) Overview of the current Immigration Law environment; (2) employment of faculty and researchers under the H-1B category; (3) processing for foreign professionals under the North American Free Trade Agreement ("NAFTA"); as well as (4) filing for permanent residency under (a) the Outstanding Professor/Researcher Category; (b) Regular PERM and Special Handling Labor Certification process; and (c) National Interest Waiver requests.

We will also address issues as they relate to Retrogression (backlog in the permanent residency process), Adjustment of Status (the last stage of the permanent residency) process, employment authorizations for dependents, filing fee and processing times, as well as the latest developments with Department of State's PIMS visa processing system.

In this webinar, the following two speakers will deliver the program:

### Mark P. Popiel, Esq. (Bond, Schoeneck & King, PLLC)
