Executive Order 202.43

Licensed Premises must “inspect, monitor, and otherwise supervise the area” within 100 feet of its business. Such supervision must ensure that any consumption of food or beverage complies with the following:

1. Local open container ordinances;
2. Social distancing; and
3. Face covering requirements.

Failure to do so may result in losing liquor license.
