Trump Administration Announces New Private Health Data Tracking System

Overview

- In July 2025, the Trump administration announced a new program in partnership with major tech companies to allow Americans to share personal health data and medical records into a private health tracking system and across multiple apps.
- The system would be overseen by the federal government through the Centers for Medicare and Medicaid Services (CMS).
- Over 60 major companies such as Amazon, Google, and OpenAI have agreed to share patient data into the system.



Overview

- The Trump administration and tech companies state this system would make it easier for patients to access health records and monitor wellness, offering a complete picture of the patient's health.
- The initiative plans to focus on diabetes and weight management.
- The system is anticipated to be released during the first quarter of 2026.
- Back in 2018, the Trump administration made a similar proposal.



Key Features of the Private Health Tracking System

- Based on an opt-in model where patients must consent to sharing their data.
- Conversational AI tools for symptom tracking and health decisions that are personalized based on the patient's data.
- Digitals tools such as QR codes and mobile apps for check-ins and medication tracking.



Data Privacy Concerns

- Risk of personal health data being accessed or misused.
- Concerns with informed consent and whether the tracking system would be utilized for the reasons disclosed.
- Skepticism associated with the security of data storage.
- HIPAA compliance and concerns about whether third-party apps would meet the federal privacy standards.



Implications and Next Steps

Potential Benefits:

- Easier to access health records
- Better understanding and comprehensive view of the patient's health
- The system is seen as a technology upgrade, bringing health care into the digital age

Potential Risks:

- Data breaches
- Misuse of personal health information and other data
- Regulatory gaps
