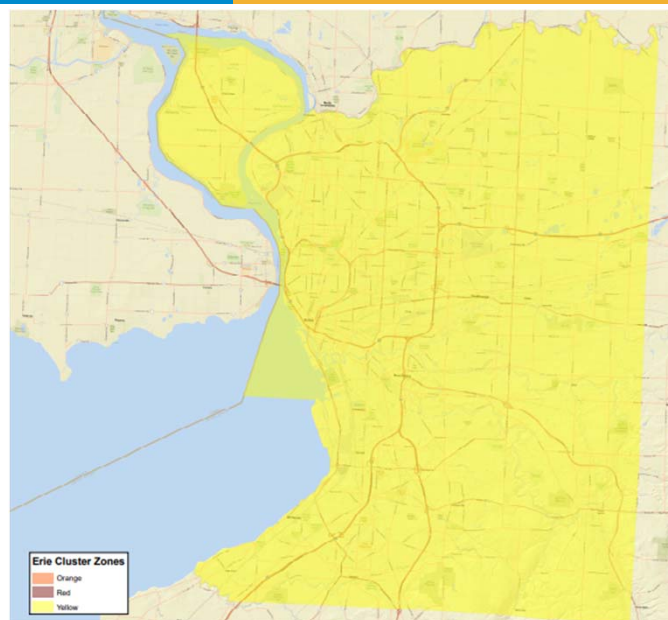

Cluster Updates

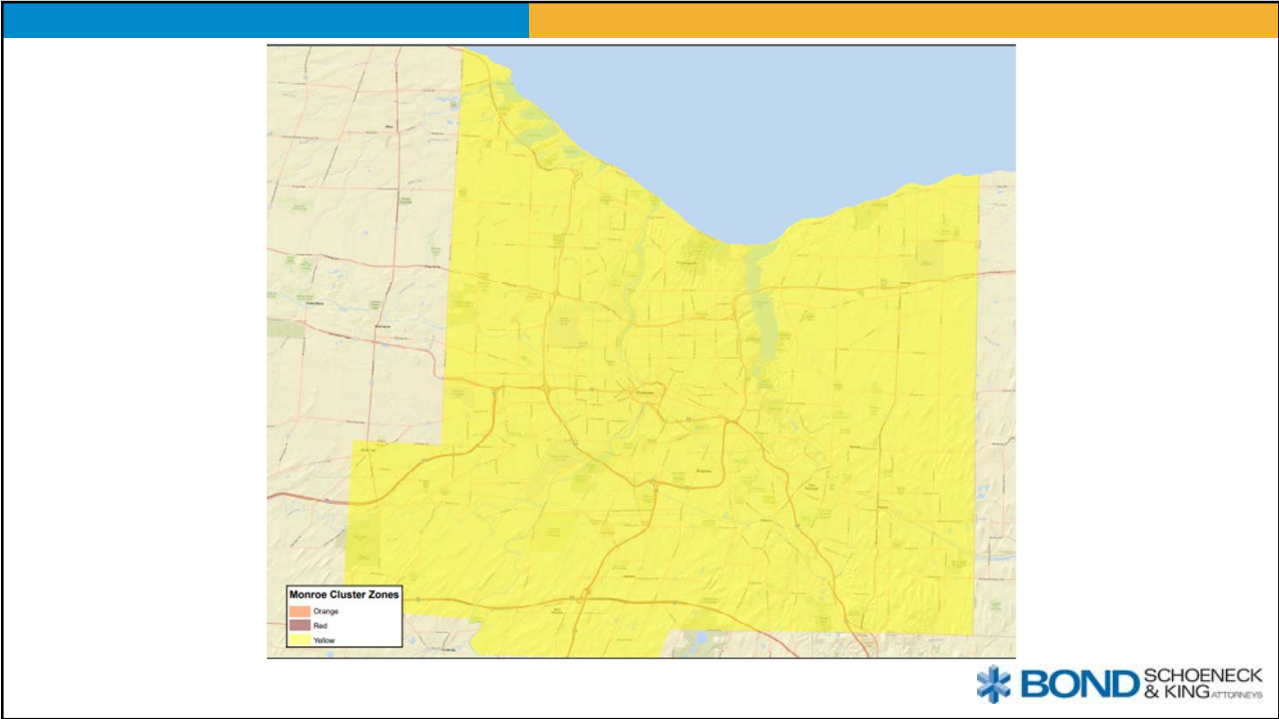
- New Yellow Zones: Erie, Monroe, Onondaga Counties

- NYC: Brooklyn (O/Y), Queens (Y)



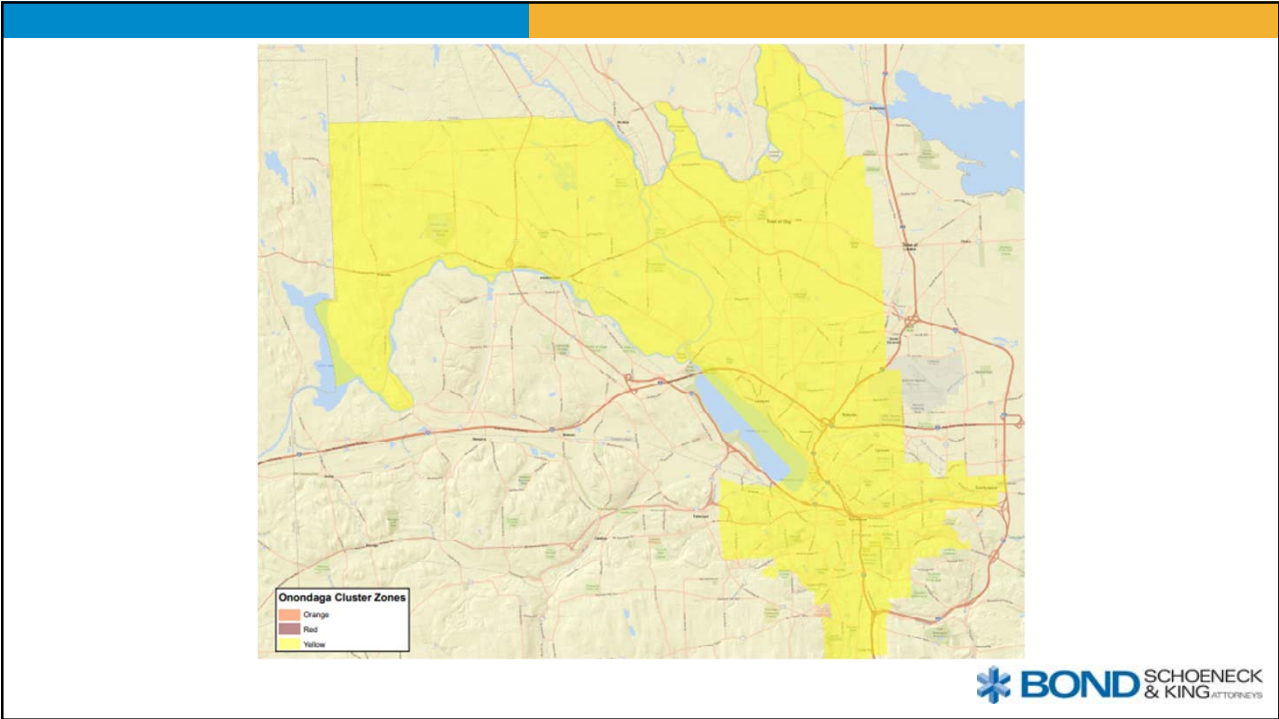

Yellow Zone Restrictions

- Non-essential gatherings are limited to no more than 25 people
- Houses of worship are subject to a capacity limit of 50% of its maximum occupancy
- Restaurants must limit any one seated group or party size to 4 people
- Schools shall adhere to applicable guidance issued by the Department of Health regarding mandatory testing of students and school personnel (test 20% of students, staff, teachers each week)
